

What Should I Know About Rivaroxaban MCP®?

- Rivaroxaban MCP® thins the blood, which prevents you from getting dangerous blood clots
- **Rivaroxaban MCP®** must be taken exactly as prescribed by your doctor. To ensure optimal protection from blood clots, never skip a dose
- You must not stop taking **Rivaroxaban MCP®** without first talking to your doctor as your risk of blood clots may increase
- Tell your healthcare provider about any other medicines you are currently taking, took recently or intend to start taking, before you start **Rivaroxaban MCP®**
- Tell your healthcare provider that you are taking **Rivaroxaban MCP** before any surgery or invasive procedure

When Should I Seek Advice From my Healthcare Provider?

When taking a blood thinner such as **Rivaroxaban MCP®** it is important to be aware of its possible side effects. Bleeding is the most common side effect. Do not start taking **Rivaroxaban MCP®** if you know you are at risk of bleeding, without first discussing this with your doctor. Tell your healthcare provider straight away if you have any signs or symptoms of bleeding such as the following:

- Pain
- Swelling or discomfort
- Headache, dizziness or weakness
- Unusual bruising, nosebleeds, bleeding of gums, cuts that take a long time to stop bleeding
- Menstrual flow or vaginal bleeding that is heavier than normal

- Blood in your urine which may be pink or brown, red or black stools
- Coughing up blood, or vomiting blood or material that looks like coffee grounds

How do I Take Rivaroxaban MCP®?

- 10 mg can be taken with or without food
- 15 mg must be taken with food
- 20 mg must be taken with food
